Executive Order #194, signed on April 16, 2023, declared the State of Emergency allowing resources throughout Wisconsin to be mobilized for the pending flooding.

Here in La Crosse, the Mississippi crested at the third highest stage of record at 15.89 feet. The two times the river had been higher were on April 18, 2001, and April 22, 1965. The stages were 16.41 feet and 17.89 feet, respectively. Fortunately, the levee reaches held and most of La Crosse stayed dry.

I am happy to report that Milwaukee is being considered for the ASFPM National Conference in 2026. This is great news for our chapter. Stay tuned for more information regarding our responsibilities to host this large event. There will be many volunteer opportunities.

2022 WAFSCM Annual Conference Recap

The Wisconsin Association for Floodplain, Stormwater, and Coastal Management (WAFSCM) held its 20th annual conference on October 19th – 20th at the Kalahari Resort & Conventions in the Wisconsin Dells. The 20th annual conference overall can be summed up as a big hit, with two misses. Let's first start with the hits:

- 1. The new 2-day format.
- 2. Inclusion of Exhibitors Reception & Social Event into the fees.
- 3. The Field Tour led by Uriah Monday from the Wisconsin Department of Natural Resources (WI DNR).

This project naturalized the Kinnickinnic River through Jackson Park by removing more than 2,100 feet of concrete channel lining and enclosed culvert.

The naturalization project will provide flood risk reduction to over 700 residential and commercial properties. Congratulations, Patrick!!


FEMA Releases Updated Local Mitigation Planning Handbook

FEMA recently released an updated Local Mitigation Planning Handbook to help local governments develop and update hazard mitigation plans to meet the current local mitigation planning policy, which took effect in April 2023. This new handbook — updated for the first time since 2013 — shows how communities can design a sound planning process while meeting new policy requirements, including climate change considerations.

Suitable for planners of all experience levels, the handbook explains the four steps to develop a local plan:

- Organize the planning process and resources.
- · Assess risk.
- Develop a mitigation strategy.
- Adopt and implement the plan.

The 253-page handbook also provides guidance, case studies, and best practices that will help communities plan to reduce long-term risk from natural disasters. <u>Download</u>
