Thank you to all the newsletter contributors and to Rhonda Janos for the newsletter preparation.






Hazard Mitigation in Wisconsin: 2018 Update

Wisconsin Emergency Management (WEM) has had an exciting and productive year! In the past year, we have received two federal disaster declarations (and the mitigation dollars that come with them), in addition to welcoming a new Hazard Mitigation Section Supervisor and a new State Hazard Mitigation Officer (SHMO). As busy as we have been, we always look forward to

continuing work with local communities to create and discover great mitigation opportunities.



In other exciting news, we have had several new grants recently approved in the Pre-Disaster Mitigation (PDM) program for Federal Fiscal Year (FFY) 17! Nineteen planning grants and three project grants were approved across the state. Mitigation planning is one of our greatest tools, because we become more resilient by understanding the hazards that we face, and what we can do about them. In this round of PDM, two tornado safe rooms in Barron County and one acquisition/demolition project in Ozaukee County were approved. We are particularly excited about the safe rooms, as they will be located in mobile home parks, including one park that was destroyed by the deadly Chetek tornado of 2017.

If your county or municipality is interested in developing a mitigation project or updating your hazard mitigation plan, WEM has several upcoming grant opportunities under the PDM program, the Flood Mitigation Assistance (FMA) program, and the Hazard Mitigation Grant Program (HMGP). The PDM program is for all natural hazards, while the FMA program is limited to flood-related hazards, and only for those communities participating in the National Flood Insurance Program. Eligible activities include acquisition/demolition or elevation of flood-prone structures, floodproofing, safe rooms, storm water detention/retention ponds, storm water management, river warning systems, and many more. The Notices of Funding Opportunity for the PDM and FMA FFY 18 programs were released August 3, 2018, and can be found at the below links:

Eligible applicants for both programs include tribal nations, state agencies, and local governments. There is a 25% required match. Interested parties must contact WEM no later than September 7, 2018.

We will also be soliciting pre-applications for the HMGP in September. This funding comes from Federal Disaster Declaration 4383, which was approved by President Trump on August 10, 2018. This declaration stems from widespread flooding in northwestern Wisconsin June 15-17 following heavy storms in the area. We anticipate that approximately \$2.5 million will be available statewide for a variety of mitigation activities that mirror the PDM and FMA programs. Eligible applicants include tribal nations, state agencies, local governments, and private non-profits. There is a 12.5% required match.

A Place in the Sun

The sun has set on ASFPM 2018 and by now I'm certain we've all had a chance to reflect on the experience. Whether this was your first time attending the annual event or you're a seasoned veteran, it's safe to say that each conference can present a few challenges. Navigating the city streets was the easy part and considering the 100 plus degree temperatures, I quickly learned to walk in the shade wherever possible. While this was the fifth national conference I've attended, I always seem to struggle selecting which sessions I want to attend. My goal in attending these events it to leave with a certain sense of accomplishment. I always want to do better for my community, thus I go with an open mind, and I always go to learn.

While choosing from the numerous session offerings can be somewhat daunting, I try to attend sessions that are practical and applicable to my community. Since we all have to deal with map revisions from time to time, I began my conference experience by attending the training workshop "From a Reviewer's Standpoint – Letter of Map Revisions and Physical Map Revisions Data Review". Having this "insiders" experience into the map revision process was extremely enlightening.

From there I ventured into the world of concurrent sessions which included presentations on the Community Rating System, Urban Stormwater Flooding, Engaging Communities, Post-Disaster Rapid Assessment, Flood Insurance – Private vs. Federal, Mitigation Grants, and finally on Thursday, I closed out the conference by attending the FEMA Showcase which I found to be both encouraging and somewhat frustrating.

If there is anything that we have learned attending this conference, it is that freeboard WORKS! One only needs to look at the recent flooding that occurred in the Houston, TX area and the loss data for pre- and post-FIRM structures. In my opinion, the time for a uniform freeboard requirement is now. Equally astounding is the fact that for every one dollar spent on mitigation, a six dollar return on investment is realized; yet we continue to spend more on disaster response than we do on mitigation.

Understanding the challenges we all face while working in the field of floodplain management, if there is one major takeaway from every conference I've attended, it's the idea that every single one of us in attendance are there for the same purpose. For me, and perhaps others on the proverbial front lines of floodplain management, the annual conference always serves to embolden and recharge the spirit and remind me that we are unified in a common cause. For that, I must thank WAFSCM for the opportunity to attend the 2018 ASFPM Conference.





ASFPM Conference Scholarship Recipient June 17-21, 2018, Phoenix, AZ

I would like to thank WAFSCM for the opportunity to go to this awesome conference. For anyone who has ever been on the fence about going to the National Conference, all I can say is, GO!

As expected, Arizona in June is hot. By the end of the conference, temperatures were around 110 degrees. The venue for this year's conference was downtown Phoenix, in an area known as Roosevelt Row. Within a couple block walk, you could find a wide variety of food and places to grab a drink. There were about 1,100 attendees this year, so it seemed like no matter where you went, you ran into people that have at least one common interest with you. And it seemed like everyone was more than willing to share their stories from back home.

The speaker lineup for the conference offered a wide variety of topics to choose from. At any given time, there were eight different tracks occurring. The general overlying theme for these included modeling, mitigation, National Flood Insurance Program (NFIP), current events, dams/levees, risk communication, mapping and storm water control. Over the course of 5 days, I attended 15 different sessions encompassing about 45 different speakers. I was able to hear strategies, anecdotal stories and lessons learned from flooding in Houston, Nashville, and Colorado. I learned about floodplain management practices and policies in the Netherlands and France. I attended sessions on dam and levee failures as well as mitigation and the NFIP. Just to mix things up a little bit, I even attended a session on recent hurricanes and their impact on life and property.

One of my favorite sessions was the International Approaches to Floodplain Management. One of the speakers studied in France and the other did extensive studies in the Netherlands. It was interesting to learn that in France, the flood maps are designed with the public in mind. There are 2 colors: red means "Don't Build", blue means "Build with extra precautionary measures." It is also interesting to note, that France, in general, regulates to the 0.2% floodplain.

My other favorite speaker was the Honorable Edward M. Emmett. As he put it, he is a judge without a court or being an attorney. He is the Chief Executive Officer of Harris County, which encompasses the City of Houston. During the flooding last year, it was his responsibility to coordinate rescue efforts and overall emergency management operations during the crisis. He talked about the challenges he and his community faced when a catastrophic event hit their county. His office had worked over the years to develop plans and procedures for when these events happen. But, he indicated that you must always remain flexible in your response. He further discussed how the city will move forward and learn from this event.

Overall, the National Conference was an amazing event. Next year, it is being held in Cleveland, and I would strongly recommend attending. Thank you again, WAFSCM.

Your Voice is Needed to Help Develop a Community Flood Risk Guidebook

Local communities have the biggest impact on whether flood hazards become disasters.

We all need places to live, work and recreate. Development is necessary within our communities as part of living in a modern world. WHERE and HOW we grow, coupled with how we ADAPT our existing risks, are the key pieces to a hazard resilient community. Ultimately, effective risk management and long-term resilience must be formed and managed at the local level.

What if proactive communities had the knowledge, skills and ability to manage their flood risk like a portfolio of assets (tracking risk like retirement investments)? Flood risk in each of our communities changes every year with growth and mitigation actions.

The Charlotte-Mecklenburg Storm Water Services in North Carolina is working on a project for Department of Homeland Security to develop a Flood Risk Guidebook that communities could use to manage their "flood risk portfolio" in the floodplain. It will be based on a Risk Assessment and Risk Reduction planning tool we developed five years ago. But your input, along with lessons we've learned, will help us refine the approach so it's applicable to a wide variety of communities (different flood types, datasets, mitigation approaches, etc.).



PLEASE HELP US HELP COMMUNITIES ACROSS THE COUNTRY. I'm asking you to provide input from a community perspective by taking an <u>18 question survey</u>. Although it will focus on floods, the guidebook concepts could have applicability to other hazards too.

FEMA Releases Initial Disaster Public Notice Regarding June 2018 Flooding

FEMA has released an initial public notice addressing the agency's intention to reimburse eligible applicants for costs to repair or replace facilities damaged by the June 15-19, 2018, severe storms and flooding in Wisconsin. This public notice concerns activities that may affect historic properties, activities that are located in or affect wetland areas or the 100-year floodplain, and critical actions within the 500-year floodplain. Such activities may adversely affect the historic property, floodplain or wetland, or may result in continuing vulnerability to flood damage. Below is a link to the FEMA posting:

XPSWMM Training: Best Practices for Floodplain Management & 2D Analysis

Hardware and software advances now allow engineers to simulate Integrated 1D/2D Hydrologic and Hydraulic simulations with reasonable simulation times. XPSWMM is a FEMA approved model for 1D and 2D hydraulics used extensively nationwide. Recent enhancements to XPSWMM now take advantage of multiple core processors and GPU cards in a new, highly parallelized scheme.

Join this 4-hour training class to learn about the new advancements in floodplain modeling using XPSWMM. In this course, you will learn about XPSWMM, the benefits and best practices for floodplain management using PSWMM, and have the opportunity to run the software to learn how to perform hydrology and hydraulics analysis. The hands-on portion of the training will provide an overview of 1D/2D Modeling. Sample models will be provided to explore how flood maps, hazard maps and evacuation routes can be developed in XPSWMM.

Attendees should bring their own laptop with the software pre-installed. Temporary license dongles and keys will be provided to users who do not have an active license. Administrative privileges are required for installation of the software, and attendees who plan to install the software during the training should have administrative privileges for their laptop.

Learning Objectives:

- Learn the capabilities of XPSWMM
- Leverage Global Storms to find critical duration that produces the worst flooding
- Understand best practices for Floodplain Management with 2D Surface Analysis

Engineering Ethics Presentation from Dr. Gaurav Bansal of the University of Wisconsin - Green Bay titled



'Does Being Ethical Make Good Visual Sense?'. The session will focus on how misrepresentation of data, bad data, and/or wrong choice of visualization could lead to incorrect perception, wrong cognition, and thus erroneous action. Poor and misleading visualizations are not only often unethical, but also inefficient and ineffective. In this session we will assess how data and design work together, including how to choose the appropriate visual representation for your data, and the difference between effective and ineffective visuals. The workshop will cover design principles and theories based on the work of eminent data visualization scientists such as William S. Cleveland and Edward R. Tufte.

Dr. Gaurav Bansal is Frederick E. Baer Professor in Business at the Austin E. Cofrin School of Business at UW-Green Bay. He is the founding chair of the Master of Science in Data Science program at UW-Green Bay, and is currently teaching courses in Data Science, Analytics, and Management Information Systems area. He received his Ph.D. in Management Information Systems (MIS) from University of Wisconsin - Milwaukee in 2008. He has an M.B.A. from Kent State University, Ohio and an undergraduate degree in Mechanical Engineering from MMM University of Technology in India. Dr. Bansal's current research interests are in the areas of user trust
